

2010 Cultus Lake Dragon Boat Festival Registration Package



Date: August 7, 2010, registration starts at 7:30 am

Location: Cultus Lake Main Beach

Event Type: Women's event

Race Course: Approximately 500 metres

Race Format: Performance in first race determines seeding into semi-finals and finals. Each team is guaranteed three races (weather permitting). Full race details to be provided at a later date. ***Note*** style of boats may vary and will be delegated by random draw.*

Festival Management: Cultus Lake Dragon Boat Club

Capacity: A maximum of **20 teams** will be accepted. Registration is accepted on a first-come-first-served basis. We encourage teams to register as soon as possible in order to secure a spot.

Registration Fee: Early bird fee of \$450 per team if registered by April 25th. Fee increases to \$500 per team after April 25th, plus the new HST tax taking effect at the end of April 2010.

Registration Deadline: June 15th, 2010

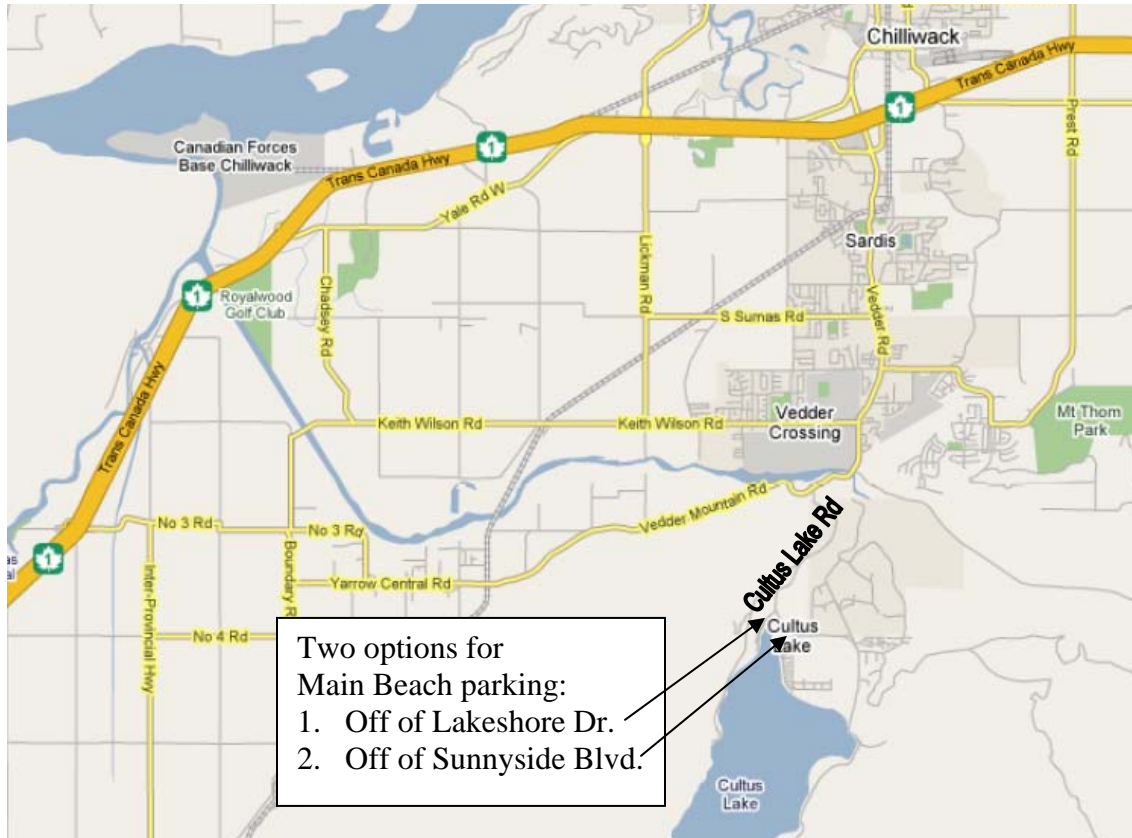

BY SIGNING THIS AGREEMENT YOU WILL GIVE UP CERTAIN LEGAL RIGHTS, INCLUDING THE RIGHT TO SUE

1. the term "dragon boat racing" shall include the 2010 Cultus Lake Dragon Boat Festival.
2. the term "Releasees" shall include the CLDBC and affiliate events, sponsors, official suppliers, officials, and all of their respective directors, officers, employees, volunteers, agents, representatives, successors and assigns.

ACKNOWLEDGEMENT - SAFETY

I am aware that the physical exertion required of dragon boat racing and the forces exerted on the body can activate or aggravate pre-existing physical injuries, conditions, symptoms or congenital defects. I HAVE ALSO READ AND UNDERSTAND THE RULES AND REGULATIONS, AND I AGREE TO ABIDE BY THOSE GUIDELINES. (Rules and Regulations are posted on the CLDBC website).

ASSUMPTION OF RISKS

I am aware and understand that dragon boat racing has inherent dangers, hazards and risks including, but not limited to:

- ACCIDENTS WHICH OCCUR WHILE LOADING AND UNLOADING EQUIPMENT
- ABRUPT WEATHER CHANGES
- COLLISION WITH MANMADE OR NATURAL OBJECTS OR OTHER PADDLERS OR BYSTANDERS
- CONDITIONS OF WATER SURFACE AND VARIATIONS IN THE WATER CONDITIONS, SURFACES AND CURRENTS
- EQUIPMENT FAILURE
- IMPROPER USE OF EQUIPMENT
- NEGLIGENCE OF OTHERS
- OVERTURNING OR UPSETTING OF THE BOAT
- FALLING FROM THE BOAT WHILE ON THE WATER
- POOR SWIMMING ABILITY OF MYSELF OR OTHERS
- FACILITY & SITE HAZARDS
- NEGLIGENCE OF THE RELEASEES
- SUSTAINED RIGOROUS PHYSICAL ACTIVITY
- TRAVEL TO AND FROM SITE
- DROWNING
- IMMERSION IN COLD WATER
- HYPOTHERMIA

I understand that injuries resulting from the danger, hazards and risks of dragon boat racing are a probable occurrence of such a sport. I am also aware that there is a risk of NEGLIGENCE ON THE PART OF THE RELEASEES, INCLUDING THE FAILURE BY THE RELEASEES TO SAFEGUARD OR PROTECT ME FROM THE DANGERS, HAZARDS AND RISKS OF DRAGON BOAT RACING.

I freely accept and fully assume all dangers, hazards and RISKS associated with participation in dragon boat racing and the possibility of personal injury, death, property damage or loss resulting there from.

RELEASE OF LIABILITY, WAIVER OF CLAIMS AND INDEMNITY

I acknowledge that it remains my sole responsibility to act in such a manner as to be responsible for my own safety and participate within my own limits. I understand that the Rules are solely for the purpose of regulating other dragon boat racing participants and me.

In consideration of the Releasees agreeing to my participation in dragon boat racing and permitting my use of their equipment and facilities, I hereby agree as follows:

1. TO WAIVE ANY AND ALL CLAIMS that I have or may in the future have against THE RELEASEES AND TO RELEASE THE RELEASEES from any and all liability for any loss, damage, expense or injury including death that I may suffer, or that my next of kin may suffer as a result of my participation in dragon boat racing due to any cause whatsoever, including negligence, breach of contract, or breach of any statutory or other duty of care on the part of the Releasees;
2. TO HOLD HARMLESS AND INEMNIFY THE RELEASEES from any and all liability for any damage or personal injury to any third party resulting from my participation in dragon boat racing; and
3. This Agreement shall be effective and binding upon my heirs, next of kin, executors, administrators and representatives, in the event of my death or incapacity.
